Agenda: The Hamden Commission on Disability Rights & Opportunities will hold a Regular Meeting via Zoom on Monday June 14, 2021 at 7:00 p.m. The following topics will be discussed:

1. Call to Order: May 10, 2021 at 7:00 pm, Ms. Delaney, Mr. Dupont, Ms. Cooney, Ms. Dobin, Ms. Frodel
Others in Attendance: ADA Coordinator Ms. Walsh, Commission Clerk Ms. Tobin
2. Review Minutes of: Ms. Delaney discussed that for the upcoming Yard Goats Game held on Sunday, June 27th at noon; she will be working on handicapped parking and is contacting the Hartford Parking Authority. Also the commission said their goodbyes to Ms. Frodel who said it was a pleasure working with the Commissioners.
3. Correspondence: There was discussion about the Yard Goat's game on how difficult it would be to try to drop off a handicapped person and leave that person to go find parking. Ms. Delaney is working with the Hartford Parking Authority. Ms. Delaney apologized to Commissioners for not sending them the application to attend the Yard Goats game. She will send it out to whoever is interested. The game is scheduled for Sunday, **June 27th at 12:00 noon**. The parking lot is on Main Street. The picnic area is open until the 9th inning.
4. Chairman's Report: Ms. Delaney had nothing further to report at this time.
5. ADA Coordinator Kathy Walsh's Report: Ms. Walsh had nothing further to report at this time.
6. Committee Reports: There was discussion of disability friendly programs and job opportunities and the need for them as well. There was mention of the Yard Goats game and the good beer they have available. Which led to Mr. Dupont stating the Thomas Hooker Brewing Company has 25% of their Bloomfield bottling operation staff with disabilities.
7. Old Business: Mr. Dupont made a motion to approve the minutes of the April 12, 2021 meeting. Ms. Frodel seconded the motion. The vote was unanimous in favor.
