Old Business

1. Hamden Cemeteries

At this time it is unknown who is in charge of writing grants for the Town of Hamden, but Mr. Levine stated that the commission can apply for the grant going forward.

In her role as Associate Director of the Hamden Public Library, Ms. Bussard is one of the hosts of the Hamden Public Library Podcast. Ms. Bussard explained that she will be interviewing Mr. Ioime and Mr. Griego from the Hamden Properties Commission, as well as Mr. Scott Howland and Mr. Tom Shillieto for this month's podcast episode. The interview will focus on State Street Cemetery and the podcast episode will go live on October 25.

2. Local Register Properties

Mr. Levine stated that they are on the agenda for November 3, 2021. Mr. Levine asked Mr. Geary to be present at the meeting in order to answer any questions regarding listing the houses they have chosen and explain that they are looking for protection for the buildings listed. This is the first step in a potential local historic district.
