

Street Trees and Your Rights as a Property Owner

Property owners have a critical role in the protection of Hamden's street trees. This document provides information and resources so property owners can act in an informed manner to insure a healthy tree canopy for Hamden's streets. Your rights vary depending on who wishes to work on a street tree.

If the Town of Hamden wants to prune or remove a street tree

- Decision to remove a tree is made by the Tree Warden – Anthony Greene – who also has the title of Superintendent of Trees. He is an employee of Hamden's Public Works Department.
- The tree must be posted by the Tree Warden and the posting notice must be dated.
- According to state law, any "person, firm or corporation" can object to the removal or pruning of a town tree (you **do not** have to be the abutting property owner).
 - Your objection must be in writing to the Tree Warden (e-mail counts)
 - A hearing will be scheduled by the Town Attorney's office
 - Tree Warden must render a decision within 3 days after the hearing
 - The Tree Warden's decision can be appealed

If United Illuminating (Avangrid) wants to prune or remove a street tree

- They need approval and a permit from Hamden's Tree Warden
- They also need consent from the abutting property owner (within time limits – see below)

When a work planner from a UI contractor (***Asplundh, Lewis Tree or another contractor***) contacts you to propose tree work, you have the right to:

- Object to the proposed work in its entirety
- Request a modification -make changes to the proposal, for example: changing their "ground to sky" pruning (in which they remove all the branches on the wire side of the tree) to directional pruning, (pruning as previously pruned) - pruning only around the wires
- Give consent to the work as proposed

If you wish to object or request a modification, it must be filed in writing (e-mail counts – trees@uinet.com and your Tree Warden agreene@hamden.com) not later than ten business days after you have been contacted by UI or their contractor.

- Should your objection or request for modification be rejected by the Tree Warden – **he must issue this in writing** - you have the option to appeal to PURA (Public Utilities Regulatory Authority) within ten days of the Tree Warden's decision.
- If you object to the proposed tree removal or pruning, **the burden of proof is on UI**. They must prove the tree is a hazard and threatens their distribution network.
